Centramax contains abamectin and albendazole, a member of the macrocyclic latone and benzimidazole family of chemicals respectively. Correct drenching technique should be used. Resistance may develop to any chemical. It is advisable that a resistance test be conducted regularly when using any parasite treatment. Ask your local veterinary practitioner or animal adviser for recommended parasite management practices for your area to reduce development of resistance.

It is effective against sensitive strains of the following internal parasites in sheep (\*includes inhibited fourth stage larvae) at treatment and for 100 days after treatment.

#### DOSE RATE

SHEEP LIVEWEIGHT	DOSE
40 - 80kg	1 Capsule
80 - 160kg	2 Capsule

Do not use at the same time as any other selenised fertilizer, prill or product and do not exceed the stated dose or frequency without consulting a veterinarian.

#### WITHHOLDING PERIODS

It is an offence for users of this product to cause residues exceeding the relevant MRL in the Food Notice:

MEAT — Sheep producing meat or offal for human consumption must not be sold for slaughter either during or within 128 days of the last treatment.

MILK — Milk intended for sale for human consumption must be discarded during treatment and for 128 days following the last treatment.

#### STORAGE

Store below 25°C. Store in a dry place. Keep the foil bag sealed using the zip lock. Keep away from sunlight. Stability in cold temperatures has not been assessed, if temperature drops below 0°C then discard unused product.

#### SAFETY PRECAUTIONS

TOXIC - Toxic if swallowed.

WARNING – May cause an allergic skin reaction.
Wash hands after handling. May cause allergy or asthma symptoms or breathing difficultes if inhaled. Do not breathe dust. Suspected of causing genetic defects.
Suspected of causing cancer. Suspected of damaging fertility or the unborn child. May cause harm to breast feed children. Avoid contact during pregnancy/while nursing.
May cause damage to organs (cardiovascular, liver, blood, nervous system, weight loss). Do not eat, drink or smoke when using this product. Wear protective gloves.
